## TRION BLACKSTONE GRIDDLE SWEEPSTAKES Official Rules

Please read these Official Rules carefully before entering the "TRION BLACKSTONE GRIDDLE Promo" Sweepstakes (the "Sweepstakes"). By entering the Sweepstakes, you agree that you have read and are bound by the terms and conditions set forth below as if you had signed a written contract. If you do not agree to the terms and conditions set forth below, you may not enter the Sweepstakes.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE ODDS OF WINNING. VOID WHERE PROHIBITED.

- 1. **Sponsor:** The Sweepstakes is sponsored by The Behler-Young Company, a domestic corporation located at 4900 Clyde Park Ave SW, Grand Rapids, MI 49509 (the "**Sponsor**"). No other entity is responsible for this Sweepstakes or the award of any prize.
- 2. **The Sweepstakes Period:** The Sweepstakes begins on March 1, 2025 at 12:01 a.m. Eastern Time (ET) and ends on March 31, 2025 at 11:59 p.m. ET (the "**Sweepstakes Period**"). A clock chosen by Sponsor will serve as the official time-keeping device for the Sweepstakes.
- 3. **Eligibility:** The Sweepstakes is open only to permanent legal residents of the United States (including District of Columbia), excluding Florida and New York, who are at least 18 years old as of the date they enter the Sweepstakes and who enter the Sweepstakes as described in the "Entry" section below. Every such person who enters the Sweepstakes is referred to in these Official Rules as an "Entrant," "you," or "your." Employees of Sponsor, its affiliates, parents and subsidiaries, the Sweepstakes administrator, their advertising or promotion agencies, those involved in the production, development, implementation or handling of this Sweepstakes, any agents acting for, or on behalf of the above entities, their respective parent companies, officers, directors, subsidiaries, affiliates, licensees, prize suppliers, any other person or entity associated with this Sweepstakes and/or members of their immediate families (spouses, children, siblings, parents) and/or persons living in the same household as such persons, whether or not related, are ineligible to enter this Sweepstakes or win. - 4. Entry: How to submit an entry ("Entry") for the Sweepstakes:

 $\underline{\text{Entry Option 1}}$  - Receive an entry to win one Blackstone Griddle for every four Air Bear Air Cleaners from Trion purchased.

Entry Option 2 – Mail-In Entry: In an A7-style envelope, mail one three (3)-inch by five (5)-inch lined note card listing your legal name, birth date, phone number, mailing address, and e-mail address to: "The Behler-Young Company c/o "TRION BLACKSTONE GRIDDLE Promo" at 4900 Clyde Park Ave SW, Grand Rapids, MI 49509 to receive one entry. You must include your return address in the upper-left corner of the front of the envelope. All information, both on the note card and the envelope, must be handwritten in blue ink, and, other than valid postage, no stickers, graphics, designs, or other additional markings, content, or information may be included on the entry or on the envelope. No typewritten or mechanically produced mail-in entries will be accepted.

In order to be eligible for the Sweepstakes, you must have registered with the Sweepstakes during the Sweepstakes Period. All mailed Entries must be postmarked no later than March 20, 2025 and received by March 31, 2025 to be eligible. Once submitted, Entries become the sole property of Sponsor and will not be acknowledged or returned. Entry Option 1 and Entry Option 2 will be treated equally, and neither form of entry will be given priority. Any attempted form of entry into this Sweepstakes other than as described herein is void. Any Entrant who submits more than sixty (60) Entries by any method or combination of methods will be disqualified.

- 5. **Drawing:** On, before, or about April 10, 2025 ("**Draw Date**"), Sponsor will hold a random drawing to select two (2) winners, as defined below. You do not need to be present in store to win. Non-winning entries will not be retained for any subsequent sweepstakes, contests, or giveaways. Each potential winner will be notified by phone or email within approximately two (2) weeks of Draw Date. When a potential winner is contacted by email for verification purposes, he/she will have forty-eight (48) hours to respond to the notification, or his/her Entry will be disqualified and his/her prize forfeited, and an alternate potential winner may be selected from among all remaining eligible entries. If an Entrant changes his/her email address after he/she registers, it is his/her sole responsibility to update Sponsor. Failure to update registration information may affect a potential winner's ability to receive prize. If a potential winner cannot be reached after a reasonable effort has been exerted, he/she is found to be ineligible, he/she cannot or does not comply with these Official Rules, or if prize or prize notification is returned as undeliverable, such potential winner will be disqualified, and an alternate potential winner may be selected at random at Sponsor's sole discretion from among all remaining eligible entries.
